RE: Health Information Exchange Assessment (CRISP) – Procedures for Submission

At its May 13, 2015 public meeting, the HSCRC adopted a recommendation to permit continued funding support for Chesapeake Regional Information System for our Patients (CRISP) for fiscal year 2016. The purpose of this memorandum is to provide you with your CRISP assessment for FY 2016. Hospitals' Global Budget Revenue or Total Patient Revenue will be increased effective July 1, 2015 to accommodate the assessment.

Attached you will find a summary of the CRISP Assessment for every hospital in the State. This list shows the total annual assessment for your facility and the three payments that your facility will be required to make in FY 2016. The initial payment will be due on September 1, 2015. The second payment will be due on December 1, 2015 and the third and final payment will be due on March 1, 2016.
