The purpose of this memorandum is to provide you with the new account numbers and the procedures for submitting the assessment payments for the MHIP, Uncompensated Care, and new Health Care Coverage funds for FY 2009

Attached you will find the FY 2009 MHIP and the new Health Care Coverage assessments. The FY 2009 assessment for the Uncompensated Care Fund (UCC) will be provided at a later date. In the meantime hospitals should submit the UCC FY 2008 monthly assessment utilizing the new procedures and State of Maryland Account number. Effective September 5, 2008, all hospitals will begin making payments into the funds by either Automated Clearing House Transfer (ACH) or FedWire. Attached you will find the instructions for submission for each fund by both ACH and FedWire.

In addition, hospitals will now be required to submit verification of the submission of each month's assessment to the funds, i.e., copies of the transmission from your bank, to the attention of William Hoff, Rate Analyst on or before the fifteenth of each month.

METHOD FOR ACH SUBMISSION OF PAYMENTS TO MHIP, UNCOMPENSATED CARE, AND HEALTH CARE COVERAGE FUNDS

In order to be able to remit payments to all three funds, your hospital must arrange with your bank to set up an Automated Clearing House (ACH) transfer. The State Treasurer's Office requires that the following information be included in the ACH record file as follows:

Nacha "6-8" field should contain your hospital's six Digit Medicare number followed by the letter "M"
