Re: Request for IRC Duel Reporting Data

On March 8, 2017, the Health Services Cost Review Commission (HSCRC) approved for review and public comment the revisions to the Relative Value Unit (RVU) scale for Radiology-Diagnostic (RAD), Nuclear Medicine (NUC), CT Scanner (CAT), Magnetic Resonance Imaging (MRI) and Electroencephalography (EEG). The scale was updated to reflect new codes to the Current Procedural Terminology (CPT) codes, changes in clinical practices and to eliminate RVUs developed "By Report" to ensure standardized charging practices. These revisions were established by a work group established by the HSCRC comprising of experienced financial and clinical personnel of many of the Maryland hospitals. In addition to revising the RVU scale, the work group also decided that certain imaging services are invasive in nature and should be reported in the Interventional Radiology/Cardiovascular (IRC) rate center. Therefore, hospitals will need to maintain a dual system of assigning IRC minutes for a minimum of three (3) months. The dual reporting data must be submitted along with the conversion factor calculation for RAD, NUC, CT, MRI and EEG. Attached you will find a list of services that are moving from the RAD, CT and MRI rate centers to the IRC rate center. Please note that this list is not all encompassing. Your individual facility may perform invasive procedures with imaging guidance that are not listed.

As services are moving from the RAD, CT and MRI rate center, a restated M schedule will be necessary in order to properly realign costs for the FY 2018 rate adjustment.

Attached is a template conversion worksheet to show how the IRC conversion factor should be developed. Each column is to be completed as follows:

Col. 1- Date- Enter the date the procedure was performed

Col. 2- Patient #- Do not input the patient's medical record number. For each patient, assign a non-identifying sample number that you will be able to identify in your records.

- Col. 3 CPT Code- Enter the applicable CPT code.
- Col. 4- Procedure- Report the procedures conducted for each patient for each day of the sample period.
- Col. 5- Old Minutes- Enter the previous procedure time in effect prior to January 1, 2017.
- Col. 6- Total New Minutes- Enter the new minutes for each procedure using the prescribed start/stop times as described in the IRC section of Appendix D.
- Col. 7- Conversion Factor- Conversion factor is calculated by taking the Total Minutes (Col. 5) and dividing by the amount by the Total Old Minutes (Col. 6).

Please note that in lieu of maintaining a dual reporting system, hospitals may develop an average time for each procudere that is moving to the IRC rate center and apply that the number of procedures performed in the reporting period.

The deadline to submit your Imaging conversion worksheet to the Commission is Wednesday May 31, 2017.
