### New Timeline for the Care Transformation Initiative

- Due to hospital focus on COVID-19, staff delayed the start date for the Care Transformation Initiative until January 1, 2021
  - The first CTI performance period will be six months (January 1, 2021 through June 30, 2021) and following performance periods will use fiscal years (e.g. PP2 will be July 1, 2021 through June 30, 2022)
- Staff have subsequently moved back the deadlines for developed CTI Thematic Areas, with final deadlines in October 2020
  - Initial deadlines for CTIs will be used to generate baseline data for hospitals to review before finalizing their submission in October
- We hope to reconvene the Care Transformation Steering Committee in the summer to continue developing Thematic Areas and CTIs
- Staff are monitoring the COVID-19 situation closely and may make additional adjustments to the CTI timeline

**Note:** Staff are revising the Intake Templates for all Thematic Areas. We will send updated versions to participants in summer 2020 to use when submitting final Templates by the October 2020 deadline.

# Opportunity for Additional CTI Development

- Staff are developing various modifications to existing Thematic Areas. These will include:
  - Modifications to Care Transitions CTI:
  - A. Care Transitions for patients that have a touch with a particular NPI
  - B. Care Transitions for patients that are discharged to a particular SNF
  - Care Transitions for patients with a particular number of medications
  - Modification to the Primary Care CTI:
    - Medicare beneficiaries with 2 or more visits to a primary care doctor (from NPI list) in the 12 months prior to the performance period
  - ▶ New CTI:
    - Procedure-based (CPT triggered)
- We encourage hospitals to discuss any other ideas for CTIs with us at their earliest convenience
  - ▶ Hospitals can also submit a CTI Assessment form to share these new ideas

### Data Availability in the CTP Tool

- All participating hospitals should now have access to the Care Transformation Profiler (CTP) to view their and other hospital's CTIs

- Trainings were held in April to orient users to the CTP, with the slides and recording available on the HSCRC website

# CTI Technical Support

- ▶ To help hospitals understand their baseline CTP data, HSCRC staff plan to host a user group session
  - The focus will be on how hospitals can improve their future Intake Template selections to optimize their CTI population and ensure an appropriate number of episodes are captured
  - The session will be held once hospitals are able to turn their focus away from COVID-19 activities
- In addition to the user group, HSCRC staff and CRISP are available for technical assistance calls with hospitals
  - We can help in strategizing Intake Template submissions, understanding the CTP report, running additional analytics on a CTI population of interest, and responding to any concerns or comments on the CTP or CTIs
